4. 2019 BC Athletics Annual Awards Banquet

- Date set – **Saturday, February 1, 2020 – Executive Inn (same venue)**
- Staff are beginning to gather information for the awards nominations and nominees and for the banquet program.

5. Criminal Records Checks:

- Criminal Records Checks must be in place for individuals carrying an Associate, Official or Coach membership – there are no exceptions.
- Presently these requirements are not being met in a timely manner and due to the number of outstanding CRC's it's difficult to monitor.
- Currently a member must have at least indicated the date they applied for the CRC either online or physically at a police/RCMP detachment in order for them to be able to take out a membership. Once the CRC is completed the effective dates are entered.
- I would like propose a 2 month cap on the length of time between when the individual indicates they submitted the CRC and when the confirmed CRC is received. If the effective date and the expiry date for the completed CRC is not entered on the Trackie.me database within 2 months from the time they started the process, the membership types requiring a CRC will be suspended. Once the CRC is completed the membership(s) will be reinstated.
