- Human Resources:

- This has been a year of significant change for BC Athletics, with many staff positions changing and rebuilding the BC Athletics team.
- BC Athletics currently has the following staff positions:

Safe Sport:

- Emerging "Safe Sport" priorities mean that we must proactively work together to uphold the health and wellbeing of our communities, where Athletics is known as a vibrant and inclusive sport.
- "Safe Sport" is the responsibility of all of us, where all parts play a role in the culture we
 collectively experience. BC Athletics has been working to align our governance
 practices with "Safe Sport" priorities. How we do business must reflect our vision of being
 a vibrant and inclusive sport.
- We identified gaps in our existing "Safe Sport" policies and have updated our policies to adopt the Athletics Canada Office of the Commissioner as an independent third party. They will provide both members and non-members with a mechanism to submit complaints regarding violations of the BC Athletics Code of Ethics and Conduct, where they will be evaluated and addressed in a fair and equitable manner. I am confident that this change in policy will uphold our Safe Sport values and better serve our members.

Financial Health:

 Our main revenue sources are membership fees and government funding (core funding and gaming). We were recipients of additional government funding throughout the COVID years, and we are now beginning to see a decline in these additional resources. Thus, we must be innovative in diversifying our revenue streams.

- I have identified the following potential financial risks;
 - Increasing insurance costs
 - Increased legal fees to implement the BC Athletics Disciplinary & Complaints Policy
 - Inflation as it relates to staff and non-staff compensation
 - Inflation as it relates to travel expenses (staff, officials, BC Team program)
 - No projected increases to Government of BC funding or Gaming funding
- o There are several ways we can to increase revenue;
 - Increase overall membership (improved systems and accessibility)
 - Prioritize and pursue sponsorship and partnership opportunities (clarify partnership value)
 - Add new revenue streams through new programs and/or services offered

- System/Organizational Capacity:

- Support the development BC athletics member clubs and all non-athlete roles (coach, officials, administrators etc.), where we can expand our capacity for athlete programs and development, through the following staff roles:
 - CEO advises club leaders on topics such as governance, disciplinary matters, and insurance coverage
 - Operations Manager supports club leaders with member registration through AthleticsReg
 - Coach Development Coordinator supports the development of coaches at all levels
 - Officials Development Coordinator & Working Groups supports the recruitment and development of officials at all levels
 - Track & Field and Non-Stadia Program Managers supports event directors with event hosting and sanctioning and provincial championship events
 - Intro Programs Coordinator coordinates the promotion and expansion of Run Jump Throw Wheel programs in communities in BC
 - Social Media Specialist promote BC Athletics activities and member recognition through social media channels.
