## **RENTAL TERMS AND CONDITIONS:**

- Track & Field Equipment is stored at Swangard Stadium, Burnaby.
- Renters who wish to transport the equipment to an alternative location must arrange suitable transportation and storage. Renters must also arrange a pick up an drop off time with the City of Burnaby, Swangard Stadium staff.
- Non-Stadia Equipment is stored at the BC Athletics Office, Burnaby.
- It is understood that the renter is responsible for:
  - Equipment must be returned in the same condition as when it was rented.
  - Any damage to the equipment other than caused by normal use is the responsibility of the renting party and must be reported to BC Athletics immediately.
  - Any charges for the repair/replacement of the equipment shall be charged back to the renter.
  - The renter is responsible for the proper assembly and use of the equipment and is liable for any damages or injury caused by the improper assembly and use of the equipment, to athletes, officials, volunteers, or spectators.
  - Renters must carry Commercial General Liability coverage, with a minimum of \$5 million dollars coverage.
  - Events that are sanctioned by BC Athletics do not have to produce a separate Certificate of Insurance.
  - BC Athletics must be named as an additional insured for the purpose of the competition / event for which the equipment is being used. A copy of the Certificate of Insurance naming BC Athletics must be sent to BC Athletics prior to the rental period.
- BC Athletics will invoice the renting party prior to the rental period. Invoice must be paid prior to the first day of the rental period.
